## **Show & Shine at Westview Lodge**



# **Product Spotlight: RESP**

# What is a Registered Education Savings Plan?

An RESP is a registered investment account designed to help families save for a child's education. Your contributions grow tax-free, you can utilize government grants, and then your child can make qualifying withdrawals as they attend post-secondary school. There are two types, an individual RESP (for a single child) or a family RESP (for multiple children).

## **Making Contributions & Withdrawals**

You can contribute up to \$50,000 per child without penalty. There is no yearly contribution limit, however, the Canada Education Savings Grant matches 20% only on the first \$2,500 per year. You won't receive a tax deduction for contributing, but your contributions, grants, and investment earnings can grow tax-free. When your child starts their post-secondary education, they will withdraw funds. Your contributions will be tax-free, but any grants or investment growth will be taxable for your child.

#### **Common Questions**

Can anyone open an RESP for a child? Yes, but the \$50,000 limit applies across all RESPs. If they don't want to open their own RESP, they can also contribute to the parents' RESP, with authorization.

What kind of schooling qualifies? Degrees, diplomas, certificates, or trade programs at designated Canadian institutions that are 3+ weeks long qualify. Only some International institutions qualify, and must be 13+ weeks long. Canada.ca has a master list of all qualifying institutions.

What if my child doesn't end up going to school? If you have another child, you can transfer the funds to their RESP. If not, you can withdraw your contributions tax-free at any time. Any government grants must be returned to the government. If you have RRSP contribution room, you can transfer any accrued earnings from your contributions or from grants to your RRSP.

## Scam of the Month: Romance Scams

A romance scam is when a criminal creates a fake profile on a dating app or social media. They gain your trust very quickly by faking an emotional connection, and then ask you for money. Red flags to watch out for is if someone professes feelings very fast, makes excuses to avoid meeting in person, or claims to have an urgent situation where they need funds. If you're involved with someone online, try to verify their identify, and never send them money or give out any of your personal information.



## **Compound Interest 101**

School is back in session – do you remember the basics of exponential growth? If not, here's a quick math lesson:

- Unlike simple interest (which only pays you on your original amount), compound interest accumulates on both your initial deposit and any interest you earn, so it just keeps growing!
- If you put \$1,000 in an investment that earns 5% compound interest, you'll have \$1,630 after 10 years, without even adding more. With small monthly deposits, it would grow much faster.
- Compound interest works best when you start early. The more time your money is collecting interest, the larger your future payout will be.

#### Quick Tip #1:

Don't wait to start investing. If you can scrape up any extra cash, no matter how little, it's worth it.

#### Quick Tip #2:

Reinvest your earnings. Put any interest payments or dividends you receive right back into the account.

#### Quick Tip #3:

Set realistic expectations. You won't "get rich quick", but compound interest works; slowly but surely.
